Dear Chair DeLauro and Ranking Member Granger:

I am requesting funding for El Centro de Corazon in in fiscal year 2022.

The entities to receive funding for this project are located at 7635 Canal St. in Houston, TX 77012 and 412 Telephone Rd. Houston, TX 77023.

The funding would be used to increase access to high-quality healthcare through capital improvements at two health center sites. This site at 412 Telephone Rd., specifically, provides adult primary medical care and dental services. The dental clinic needs expansion in terms of the actual physical layout and dental equipment. The minor renovation would add 306 sq. ft which will add two (2) new dental operatories, compressor, and related equipment to serve additional patients based on this request.

And the site at 7635 Canal St. would use the funds to purchase flood pedestrian gates, minimum of 2' gates, at the five (5) entrances around the health center. These services are critical when there is heavy rainfall in the area, especially since flooding frequently occurs and water runs into the building.
